1. Two names for each class both SC/ST Girl students.
2. Annual income of the Parent's / Guardian's does not exceed Rs. 60920.00 (Rupees Sixty Thousand Nine Hundred Twenty) only. Certificate should be issued from M.P. / M.L.A. / Councilor of the Municipality / Member of Zilla Parisad / Member of Panchayat Samity / Group 'A' Officer of the state Govt. / Gazetted Officer of the Central Govt. In case salaried person's income certificate should be given by the Employer.
3. Minimum 75% attendance in the school.
4. The students will have to obtain at least qualifying marks for promotion.
5. The Students will be selected on the basis of marks obtained in previous classes in the academic session for the year 2019.
6. The proposal should be sent to this office in the pro-forma given in the overleaf. (Computer Print)

1. Annual income of the Parent's / Guardian's does not exceed Rs. 36000.00 (Rupees Thirty Six Thousand) only. Certificate should be issued from M.P. / M.L.A. / Councilor of the Municipality / Member of Zilla Parishad / Member of Panchayat Samity / Group 'A' Officer of the state Govt. / Gazetted Officer of the Central Govt. In case salaried person's income certificate should be given by the Employer.
2. Minimum 75% attendance in the school.
3. Minimum marks should be obtained 60 % for SC and 40 % ST. (excluding Addl. Subject)
4. Students on the basis of the result in last annual examination for classes VIII to IX be awarded, and on the basis of the result of last Madhyamik Examination held in 2019 the students may also be awarded for reading in class XI in 2019-20. Candidates awarded for classes IX and XI in the year 2018-19 will be considered for class X and XII respectively provided they pass in the final examination the last academic year and continuing their studies.
