In this regard he/she is req inform the schools for re-registration on NSP2 especially those schools from where students are selected for NMMSS Scholarship. If any school fails to do so on NSP and the registration of school is not approved by concerned DI/S (SE) end the school can not verify the registration of selected candidates. It is seen from NSP regarding status of fresh registration that 90% app (the students who have applied already) are pending at school end for first level verification. So, schools authority may be informed as soon as possible for verification of the same without a
