ORDER

As per the existing rules/provision, Assistant Teachers of Schools/Madrasahs are normally allowed four increments during their first five years of service within which they are required to complete the B.Ed Course approved by NCTE. There are many untrained Teachers in recognized High Madrasahs (including Junior High) /Senior Madrasahs under this Department having Mumtazul Muhaddethin, Kamil or Fazil qualification who did not get the scope to undergo B.Ed course as there was no such course in any institute in the State providing any method subjects of MM, Kamil and Fazil until it was introduced in the year 2013-14. Some of these untrained teachers were granted incremental benefit in terms of the order of the School Education Department, Government of West Bengal.

In the recent past, while processing pension papers of some such untrained teachers, clarifications were being sought from different sections regarding the eligibility of drawal of annual increment in their respective scale of pay beyond five years of their service.

Considering all aspects of the matter, the State Government has decided to grant a one-time relaxation for allowing annual increments in favour of untrained Assistant Teachers of High Madrasah (including Junior High)/Senior Madrasah having qualification of Fazil/Kamil/MM up to 01.07.2015 on the condition that no further relaxation will be allowed thereafter. However, such teachers who have already retired or will retire within 30.06.2019 may be allowed increment(s) up to 01.07.2018 because of their overage to undergo such training at the fag end of their career/just prior retirement.

This has the approval of the Finance Department vide their U.O. No. Group P1/2018-2019/0229 dated 05.09.2018.
