In reference to the above noted subject the undersigned has to inform that all pending Fresh Pension Applications will be processed strictly in accordance with the above noted reference letter. A copy of the same is annexed herewith for reference and all are requested to go through the said letter. Applications pending at any level will be sent to the DPPG with the revised pay as per ROPA 2019. Actions may be taken as noted below :-

1. Necessary arrangement for inclusion of revised pay(as per ROPA 2019) have to be made.
2. Vetted Option(Annexure-II) & Fixation(Annexure-III) of ROPA 2019 to be distributed shortly from this office. In this regard notice will be published in our office website (www.disebankura.in) very soon.
3. Collection of objected Pension file and re-submission of the same to be done on Monday, Wednesday and Friday of every week. **Monday** (Bankura Sub-Division), **Wednesday** (Khatra Sub-Division) and **Friday** (Bishnupur Sub-Division). Submission of Fresh pension applications will also be made as per this weekly schedule.
- 4. Required papers for fresh Pension Application of each employee has to be submitted in a separate cover file mentioning School Name, Sub-Division name ,contact no of Pensioner & the HOI.**
5. Necessary safety measures to be taken from this end at the time of returning and receiving the pension files as per Covid 19 guidelines.

This to draw your attention to the fact that e-Pension Portal has been customised and updated with Pay under ROPA, 2019 in terms of Notification No. 437-SE(P&B)/SL/55-408/19 dated 13/12/2019 issued by School Education Department, Govt. of West Bengal.

Pension application for Employees who have retired/ died on or after 01/01/2016 and pension applications have not been submitted to this Directorate till date can now be updated with revised pay under ROPA, 2019.


Pension Application has to be initiated/ resubmitted by the Applicant choosing ROPA, 2019 against "Last Pay drawn under" in Part-A.

Head of the Institutions/ Sub-Inspector of Schools (Primary Education) has to fill up Part-D in accordance with the revised pay under ROPA, 2019.

To avoid duplication of work at all levels, it may be ensured that all the pending pension applications are submitted to DPPG, WB only after updating pay as per ROPA, 2019.


