Sub: Regarding circulation of message to the Head of the Institutions as well as students whose payment of NMMSS has been failed due to technical reason.

With reference to the subject mentioned above this is to inform you that it has been reported from Students end as well as Institution end that Payment of scholarship of NMMSS has been failed due to different technical reason such as- change of IFSC Codes, students name not matched with bank A/Cs ,wrong entry of IFSC Codes etc. In case of NMMSS, Govt. of India disburses scholarship of NMMSS through DBT mode into students' individual bank a/c (s). **Now our office has come to know that the students whose payment has been failed have received a message in his/her mobile (which is registered in NSP2) for updating the correct bank a/c s as well as IFSC codes at NSP2 using students individual user ID & password (Log in year for fresh 2020-21 for 2019 qualified students and renewal 2020-21 for renewal students) within 24/07/2021.** After that students will not get any chance to update the same. If any student do not get any message though his/her payment has been failed is also requested to update the same within 24/07/2021. It is to be done by the individual student at his/her end.

So, all districts Inspector of schools (SE) are requested to circulate the message to all Institutions under his/her jurisdiction and inform the Head of the Institutions as well as students so that students can update their bank A/Cs within 24/07/2021 without fail. Screenshots of the process in respect of a student are enclosed herewith.
