Sub: Regarding Authentication of Register of Appointment(ROA) due to change of Appointing Authority of Headmaster/Headmistress / Teaching and Non teaching staff of his/her school.

Ref:- Memo no- 1112(23)-SE/S/10M-95/17 Dated-20/12/2021 of the Assistant Secretary to the Govt. of West Bengal, School Education Dept.

This is to inform all HOI of Schools under the control of this office, that as per subject & reference stated above he/she is requested to update Register of Appointment(ROA) for further vacancy related works. At the time of preparation/updation of Register of Appointment(ROA)the following point should be kept in mind.

- a) Register of Appointment(ROA) will be maintained separately one for Teaching & other for Non-Teaching staff.
- b) Both for Teaching & Non -Teaching vacancies two separate Registers of Appointment(ROA) have to be maintained 1) one upto 7-3-2018 and this register will be authenticated by the BCW Department **only for those vacancies occur before 8-3-2018** and other 2) w.e.f 8-3-2018 to till date which **need not be authenticated by the BCW Department** and no need to write roster point column but all other columns should be filled up properly.

It is needless to say single non teaching post sanctioned & HM will not come under this perview.

All are requested to submit ROA Register both for Teaching & Non Teaching to the Office of the Po Cum BCW , Bankura for authentication.
