MEMORANDUM

In this Department Order No. 274-SE(P)/PBRPSUS/ADMN/9/04-05 dated 23.04.2010 the benefit of an ex-gratia Retirement Honorarium amount of Rs.1 (one) lakh has been extended in favour of the Part Time Contractual Teachers of Higher Secondary section on attaining the age of 60 years.

In terms of the circular No. 380-SE/S/1M-04/2020 dated 29.03.2022 yearly enhancement of remuneration @ 3% has been allowed w.e.f. 01.12.2021. Again, terminal benefit of Rs. 3 lakh also has been allowed in the same order w.e.f. 01.12.2021.

In view of the above, the undersigned is directed to say that

1. the Head of Account for such payment will be – "2071-Pension & Other Retirement Benefits-01-Civil-104-Gratuities-00-007-Payment of Gratuity to Part Time Teachers (PTT) and Contractual Whole Time Teachers (CWTT)-04-Pension/Gratuities-V", under Demand No.18.

And

2. The District Inspector of Schools (S.E.) of the District will be designated as the sanctioning authority for the purpose.

The District Inspector of Schools (S.E.) will be authorised to grant such benefit to all those Part Time Contractual H.S. Teachers who have retired before 01.12.2021 upon examination of the following :-

- A. The Contractual H.S. Teacher was appointed to a sanctioned part-time post.
- B. Such Contractual H.S. Teacher has remained in such service without any break.
- C. Retirement date of such Contractual H.S. Teacher will be counted on the last day of the month in which he attained 60 years of age or that of the previous month, if born on the first day of the next month.

The date of next enhancement of remuneration of these Contractual H.S. Teachers will be 01.12.2022 as the Finance Department allowed enhancement of remuneration @ 3% w.e.f. 01.12.2021.

The Principal Accountant General (A&E), West Bengal and all other concerned are being informed accordingly.
