

Sub: Different issues regarding scholarships during 2022-23

Sir,

In continuation of this Directorate memo no.167(P)-BCWTD dt. 01.09.2022 you are further informed that despite the fact that online verification of Scholarship applications have been initiated, usual verification of hard copies of applications will continue to be in practice. PO-cum-DWO / DWOs and Inspectors should exercise with due care while verifying the scholarship cases. It is also advised to properly verify the parameters with the hard copies properly. Date of birth has to be verified with birth certificate of the student, admit card and in extreme cases declaration by the HM of the institution in the letter pad of the school about the date of birth of the applicant. In some cases, it is seen that the applicants are using the 'Surnames' which normally do not belong to that particular Cast/Tribe to which he or she is professing to belong. These cases are to be properly explored during verification. You are also requested to hold meeting with the school authorities and DIs of the district as well with the IBCWTDs to apprise them of the current guidelines and procedures to be followed. IBCWTDs may also be advised to keep their DSCs in proper custody so that misuse can be arrested.
