
In order to comply with the Hon'ble Court's order dated 19.01.2023 passed by Hon'ble Justice Biswajit Basu in WPA 24451 of 2022, verification of particulars of appointment of teachers appointed in Government Aided/ Sponsored Schools through post 2016 selection process is going on. It is found that a good number of teachers appointed and joined in this district through post 2016 selection process but subsequently transferred to another District on General/ Mutual transfer. Verification of particulars of appointment of such teachers will be held on 30.01.2023 & 31.01.2023 from 11.00 AM to 4.00 PM at the office of the undersigned.

The concerned Headmaster / Headmistress/T.I.C of Junior High/ High/ Higher Secondary Schools are requested to appear in person or through their authorized representative along with the teacher(s) concern to furnish the following documents in original along with one set of attested photocopy of each document.

- 1) CSSC's recommendation letter for appointment of such teachers (both school's copy and candidate's copy)
- 2) Appointment letter issued by WBBSE of such teachers (both school's copy and candidate's copy).
- 3) First joining report of such teachers.
- 4) Approval of appointment of such teachers.
- 5) Document in support of Caste/Category (if appointed against Reserved Category)
- 6) Testimonials in support of educational qualification.
- 7) CSSC's recommendation letter for transfer of such teachers (both school's copy and candidate's copy).
- 8) Transfer order issued by WBBSE of such teachers (both school's copy and candidate's copy).

The concerned Headmaster / Headmistress/T.I.C of Junior High/ High/ Higher Secondary Schools are also requested to inform such teacher(s) to appear on the above mentioned dates & venue along with above mentioned documents in original for verification.

The schools, those who will not turn up in verification process as per scheduled date and time may face legal consequences that may arise in future.


