Sub: Regarding verification of particulars of appointment

Ref: Solemn order of the Hon'ble Justice Biswajit Basu passed on 19.01.2023 in WPA 24451 of 2022 (Soma Roy –Vs.- The State of West Bengal & Ors.)

In order to comply with the Hon'ble Court's order dated 19.01.2023 passed by Hon'ble Justice Biswajit Basu in WPA 24451 of 2022, verification of particulars of appointment of Headmaster/Headmistress appointed in Government Aided/ Sponsored Schools through post 2016 selection process (1st SLST(HM), 2017) is also to be done. It may be the case that;

A. Headmaster/Headmistress got appointment in the district of Bankura and is working in that post in this district till date.

B. Headmaster/Headmistress got appointment in the district of Bankura and subsequently transferred to a school of another district.

C. Headmaster/Headmistress got appointment in a school of other district and subsequently transferred to a school of the district of Bankura.

Verification of particulars of appointment of Headmaster /Headmistress of all three categories noted above will be held on 07.02.2023 & 08.02.2023 from 11.00 AM to 4.00 PM at the office of the undersigned.

The concerned Headmaster / Headmistress of Junior High/High/ Higher Secondary Schools are requested to appear in person on 07.02.2023 or 08.02.2023 to furnish the following documents in original along with one set of attested photocopy of each document.

- 1) CSSC's recommendation letter for appointment as Headmaster/Headmistress (both school's copy and candidate's copy)
- 2) Appointment letter issued by WBBSE as Headmaster/Headmistress (both school's copy and candidate's copy).
- 3) First Joining report and subsequent joining report (in case of transfer) as HM
- 4) Approval of appointment as HM
- 5) Document in support of Caste/Category (if appointed against Reserved Category)
- 6) CSSC's recommendation letter for transfer (both school's copy and candidate's copy), if applicable.
- 7) Transfer order issued by WBBSE (both school's copy and candidate's copy), if applicable.

In respect of Headmaster/Headmistress of category "B" as stated above, the concerned Headmaster / Headmistress/TIC of Junior High/ Higher Secondary Schools are requested to inform them to appear on the above mentioned dates & venue along with above mentioned documents in original for verification.

The Headmaster/Headmistress who will not turn up in verification process as per scheduled date and time may face legal consequences that may arise in future.

Note: If verification of documents of any teacher in terms of this office Memo No. 15/LS dated 20.01.2023 and 17/LS dated 27.01.2023 is pending he/she also has to attend for verification on 07.02.2023 or 08.02.2023.
