

West Bengal Board of Secondary Education vide its Notification bearing Memo No. 125/Sec/23 dated 22/04/2023 has, in compliance of the solemn interim order dated 12/04/2023 of the Hon. Supreme Court of India in case –CA No. 2419 and 2420 of 2023 (Gopinath Bhanja & others-Vs.- State of West Bengal and others) etc., kept the following orders of West Bengal Board of Secondary Education in respect to cancellation of Appointment Letters (i.e. Class IX-X and Group C & D Cases) in abeyance until further order:

Now, the West Bengal Board of Secondary Education has informed vide its Memo No. 145/Sec/23 dated 08<sup>th</sup> May, 2023 that in accordance to the solemn interim orders passed by the Hon. Supreme Court of India and letter of the West Bengal Central School Service Commission vide Memo No. 539/L-6594/CSSC/ESTT/2023 dated 08/05/2023, the appointment letters of the concerned candidates, as was issued by the West Bengal Board of Secondary Education, stands valid as of now, until further order of the Hon. Supreme Court of India.

This is for your information and necessary action, following due process.


