Supreme Court of India and letter of the West Bengal Central School Service Commission vide Memo No. 539/L-6594/CSSC/ESTT/2023 dated 08/05/2023, the appointment letters of the concerned candidates, as was issued by the West Bengal Board of Secondary Education, stands valid as of now, until further order of the Hon. Supreme Court of India.
